

# OAK CREEK CDD POOL RULES

1. Pool hours: **NOV - FEB 7AM - 6:15PM** **MAR - OCT 7AM - 8:00PM**
2. If you have an emergency, call 911
3. No one is permitted in the pool outside of pool hours unless the event is CDD approved.
4. Members must have, always in their possession, their access card.
5. **GUESTS are limited to 4 per household** and must be accompanied by an **adult member (18 years or older)**
6. **No one under the age of 16** is allowed in the pool area unless accompanied by an **adult member (18 years or older)**
7. All under the age of 10 must be directly always supervised by an adult member in the water or from the deck.
8. The pool is not able to be reserved for any parties or private functions.
9. No running or horseplay is allowed in the pool, pool deck/area or wet areas.
10. SWIM AT YOUR OWN RISKS. The pool areas are not supervised by lifeguards.
11. All swimmers must shower before initially entering the pool.
12. Small balls, rings or toys should be kept at a minimum when other bathers are present.
13. The pool's emergency flotation rings are not to be used as a toy.
14. NO BBQ grills are allowed in the pool deck/area.
15. Members are responsible for cleaning up after themselves.
16. Smoking/vaping in the pool deck/area is prohibited.
17. Animals are not permitted on the pool deck/area except for service animals.
18. Dives, flips, back jumps, or other dangerous actions from pool side are prohibited.
19. Persons with open cuts, wounds, sores, or blisters may not use the pool.
20. No person should use the pool with/suspected of having a communicable disease, which could be transmitted via the pool.
21. Flotation devices, such as rafts are not allowed in the pool. Swim aids & aquatic exercise equipment are permitted.
22. **Alcohol is strictly prohibited** anywhere at the amenity center. Glass containers or breakable objects of any kind are not permitted in the pool fenced in area but is permitted in designated areas outside the pool fenced in area.
23. No food or beverage are allowed in the pool and or within 4 feet of the pool edge.
24. Drones/bicycles/scooters/roller skates/rollerblades/roller shoes/skateboards & anything with wheels, are not permitted on the pool deck.
25. Appropriate swimming attire (swimsuits) must be always worn. No thong swimwear is permitted at the facility.
26. Infants/children not toilet trained, and incontinent persons must wear snug plastic or rubber pants under their swimsuits when using the pool facilities. Diapers (cloth or disposable) are prohibited.
27. Only authorized staff members are allowed in the filter area, storage room, shed and staff office.
28. Tables or Chairs on the deck area may not be reserved by placing towels or personal belongings on them.
29. Pool may be closed due to weather warnings, fecal accidents, chemical balancing, or general maintenance & repairs.
30. The Pavilions and outdoor grills are available on a first come, first serve basis – unless previously reserved.
31. All swim instructors/independent contractors must be approved, certified, insured & must have a CDD contract.
32. Pool Policies, including hours of operation, may be changed at the discretion of the District's Board of Supervisors.
33. In the event of rain, the pool is closed.
34. LIGHTNING - PLAN OF ACTION according to the NATIONAL LIGHTNING SAFETY INSTITUTE <http://lightningsafety.com> When lightning or thunder is observed everyone must EXIT THE POOL, POOL DECK & AVOID THE WATER. If lightning is striking nearby, you should Avoid proximity - minimum of 15 ft. to other people or metal fencing. *SPEND ACTIVITIES for 30 MINUTES after the last observed lightning or thunder.*
35. Failure to abide by the rules may result in a warning and or immediate dismissal from the area and or suspension of amenity card, a reactivation fee and or Trespassing depending on severity of violation. Below is the suspension process, HOWEVER VIOLATIONS RELATED TO VANDALISM OR THE SAFETY AND HEALTH OF THE COMMUNITY AND ITS RESIDENTS WILL BE REVIEWED AND MAY RESULT IN ALL OF THE BELOW. All other general facility rules apply. \*\*\*\*\*Residents will be notified of their offense & action taken against the household.
